



**TEMPORARY CLOSURE AND RESTRICTIONS OF VARIOUS ROADS FOR  
CHELTENHAM RACECOURSE EVENTS TRAFFIC MANAGEMENT  
(VARIOUS WARDS) CHELTENHAM BOROUGH AND TEWKESBURY  
BOROUGH**

Gloucestershire County Council intend to make an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close and restrict part of the lengths of roads as detailed in the Schedules below.

**SCHEDULE 1 - One Way/ Tidal Flow System**

<b>Road</b>	<b>Description</b>	<b>Direction of Flow</b>
A40 London Road	which extends from its junction with the south-eastern kerb line of Old Bath Road to its junction with the north western kerb line of Sandford Mill Road.	from Northwest to Southeast
Old Bath Road	which extends from its junction with the northern kerb line of Sandford Mill Road to its junction with London Road	from Southwest to Northeast

**SCHEDULE 2 - Prohibition of Driving**

A435 Evesham Road (10am to 8pm) SOUTHBOUND ONLY <i>This restriction will be lifted between the hours of 1:30pm &amp; 4:30pm approx if safe to do so.</i>	From Hyde Lane / Southam Lane junction to the Racecourse roundabout with the exception of Racecourse Labelled vehicles. (The actual closure will be at gate 8/9 where non-labelled traffic will be turned around).
B4075 New Barn Lane (3:30pm – 7pm) <i>To be closed to through traffic only for approximately 2 hours within this period depending on time of last race.</i>	From A435 Evesham Road (Racecourse Roundabout) to Albert Road. To enable a sterile area post race for safety of pedestrians leaving Cheltenham Racecourse.
Albert Road (10am to 1pm) and	From its junction with New Barn Lane to Prestbury Road, except for the purpose of obtaining access to premises in

(4pm to 8pm)	Albert Road or to premises where access can only be obtained from Albert Road, or for use by buses, taxis and horseboxes.
Voxwell Lane (3:30pm to 8:00pm)	From its junction with Two Hedges Road to the A435 Evesham Road except for the purposes of obtaining access to premises in Voxwell Lane or to premises where access can only be obtained from Voxwell Lane, or for use by buses.
Hill Court Road	From its junction with Evesham Road to Albert Road, except for the purpose of maintaining access to premises in Hill Court Road or to premises where access can only be obtained from Hill Court Road or for use by buses.

### **SCHEDULE 3 – 30MPH SPEED RESTRICTION**

<b>Road</b>	<b>Side</b>	<b>Description</b>
A435 Evesham Road	Both Sides	From the Hyde Lane/Southam Lane junction to Racecourse Roundabout. To be in place 24/7 on race days.

### **SCHEDULE 4 - Restrictions at Kingsditch Mini Roundabouts**

<b>Road</b>	<b>Time</b>	<b>Restriction</b>
C85 Kingsditch Lane/ Wymans Lane	4:30pm – 7:30pm	Closed to traffic travelling south at its junction with Runnings Road. Traffic exiting Runnings Road will be prohibited from turning right.
C9046 Swindon Road	4:30pm – 7:30pm	Closed to traffic travelling in an eastbound direction at its junction with Kingsditch Lane. Traffic exiting Swindon Road will be prohibited from turning right.

### **SCHEDULE 5 – Waterfilled Barrier Install/Removal**

<b>Road</b>	<b>Time</b>	<b>Restriction</b>
A435 Evesham Rd  <i>To be used the night before the first race day and the night following the last race day</i>	7:00pm – 5:00pm	Closed to traffic travelling north at its junction with Swindon Ln/New Barn Ln.
A435 Evesham Rd  <i>To be used the night before the first race day and the night following the last race day</i>	7:00pm – 5:00pm	Closed to traffic travelling south at its junction with Swindon Ln/New Barn Ln.

**SCHEDULE 6 - NO WAITING 7am to 2pm with the exception of buses**

<b>Road</b>	<b>Side</b>	<b>Description</b>
Pittville Street	Both Sides	From a point 15 metres north-east of its junction with High Street for a distance of 58 metres in a north-easterly direction

**SCHEDULE 7 - NO WAITING 10am to 2pm with the exception of buses**

<b>Road</b>	<b>Side</b>	<b>Description</b>
Gloucester Road	Both Sides	From its junction with the A40 to its junction with Libertus Road

**SCHEDULE 8 - NO PARKING/ NO WAITING 10am to 8pm**

<b>Road</b>	<b>Side</b>	<b>Description</b>
490224 Mandarin Way	Both Sides	From its junction with Windyridge Road to the junction of Seneca Way for a distance of 490 metres.

**SCHEDULE 9 - SUSPENDED ORDERS**

Articles 5 and 7 of The Borough of Cheltenham (Promenade) (Prohibition of Buses and Pedal Cycles) Order 1991 [Variation to the Borough of Cheltenham (Central Area) (Pedestrian Priority) Order 1987]

**SCHEDULE 10 – WARDS AND PARISHES**

The Roads described in Schedules 1 to 7 fall into the Parishes of Prestbury and Swindon of Cheltenham Borough; the Wards of Battledown, Charlton Park, College, Pittville, Swindon Village, Cleeve Grange, Cleeve West and Cleeve Hill of Cheltenham Borough; and Parishes of Bishops Cleeve and Southam of Tewkesbury Borough

**Please note that other roads may be affected at the discretion of the police to aid the safe passage of traffic.**

The reason for the closures and restrictions is to manage traffic during major events at Cheltenham Racecourse.

The roads are expected to be closed and restricted at certain times between the 11<sup>th</sup> March 2024 and 1<sup>st</sup> January 2025. The Jockey Club will provide at least 28 days notice to Gloucestershire County Council for any such event. It is likely that it will be predominately in use from 12<sup>th</sup> March 2024 to 15<sup>h</sup> March 2024 and 8<sup>th</sup> November 2024 to 10<sup>th</sup> November 2024 and also 1st January 2025. The presence of approved signage will indicate whether the restrictions are in place.
